

Hyde Park Residence

Main priorities were access from the deck/concrete pad to the upper flat area of the yard, allowing the swale to continue to drain properly, and plantings for screening on both sides. Stone steps allow access to the back and side yard with new plantings on the slope and




around all property lines.

-) PLANTING BED PREPARATION: LOOSEN EXISTING SOIL, ADD TOPSOIL IN SUFFICIENT QUANTITY TO PROVIDE POSITIVE DRAINAGE AWAY FROM ALL BUILDINGS AND AROUND OR AWAY FROM RAISED BEDS TO PREVENT PONDING OF WATER. DO NOT RAISE BED GRADES, FINISHED GRADES, OR MULCH ABOVE FINISHED FLOOR ELEVATIONS.
- 3) ALL SUBSTITUTIONS OF VARIETIES ARE SUBJECT TO APPROVAL OF LANDSCAPE DESIGNER.
-) MULCH ALL FOUNDATION PLANTINGS WITH A MAX. 6" DEPTH OF PINE STRAW (WHEN DRY).
- ALL NYLON ROPING, TWINE SHALL BE REMOVED PRIOR TO PLANTING. ALL NON TREATED BURLAP AND/OR ROT PROOF BURLAP TO BE REMOVED FROM TOP HALF OF ROOT BALL. ALL TREATED BURLAP TO BE COMPLETELY REMOVED FROM PLANTING AREA.
-) ORGANIC FERTILIZER 19-6-12 TO BE APPLIED TO ALL PLANTING AREAS PER MANUFACTURER APPLICATION INSTRUCTIONS.
- 0) THE LANDSCAPE CONTRACTOR IS RESPONSIBLE FOR HAVING ALL UTILITIES MARKED BY OUPS BEFORE WORK COMMENCES.
- 1) IF DEER DAMAGE FROM RUTTING IS A POTENTIAL ISSUE THEN ALL SINGLE STEM TREES TO BE PROTECTED WITH INDIVIDUAL DEER GUARDS MADE FROM RIGID MESH MATERIAL AND ATTACHED WITH ZIP TIES.
- 2) IF DEER DAMAGE FROM RUTTING IS A POTENTIAL ISSUE THEN ALL MULTISTEM AND WEEPING ORNAMENTAL TREES TO BE PROTECTED WITH MESH FENCING HELD IN PLACE BY 4-6' TALL STAKES (QUANTITY 3-4) FROM AUGUST UNTIL FEBRUARY.
- 3) PROVIDE RIVER ROCK BED, MIN. 2-3" DEEP. PROVIDE LANDSCAPE FABRIC AND PIN-IN-PLACE BENEATH ALL RIVER ROCK APPLICATIONS.




